Re: Termination of Security Interest

Ladies and Gentlemen:

Reference is made to the indenture (the "Indenture"), dated as of August 1, 2003, among MSX International, Inc. and MSX International Limited (the "Issuers"), the Guarantors named therein and BNY Midwest Trust Company, as trustee (the "Trustee"), relating to the Issuers' 11% Senior Secured Notes due 2007 (the "Notes"). Capitalized terms used and not otherwise defined herein have the meanings set forth in the Indenture.

You have previously given notice pursuant to Section 3.1(b) of the Indenture of the redemption of the Notes at a price equal to 100.00% of the principal amount thereof with accrued interest to, but not including, May 4, 2007. Pursuant to Section 3.2 of the Indenture, we have, at your request and on your behalf, mailed, by first class mail, a notice of redemption to each Holder whose Notes are to be redeemed at its registered address in accordance with the terms of the Indenture. Trustee hereby confirms receipt of the sum of \$77,645,458.33 which it confirms is sufficient to pay and discharge the entire Indebtedness on the Notes pursuant to Section 8.1(a) of the Indenture. The Trustee hereby acknowledges full satisfaction and discharge of the Indenture pursuant to Section 8.1 of the Indenture. Accordingly, consistent with Section 10.5 of the Indenture, the Trustee hereby terminates the Collateral Agreements, and terminates and releases any and all security interests, pledges, assignments and liens created pursuant thereto. The Trustee hereby authorizes each of you and your affiliates, either directly or through your respective attorneys and agents, to prepare and file on behalf of the Trustee, as the secured party of record, uniform commercial code termination statements and any other necessary termination and release documents, instruments or statements with respect to any and all financing statements previously filed in connection with the security interest granted to the Trustee under the Collateral Agreements. We hereby authorize you to deliver a copy of this letter to any bank, securities intermediary or other person holding physical possession of, or maintaining, any Collateral.
