

Trademark Assignment

THIS TRADEMARK ASSIGNMENT (this "Assignment"), dated as of April 22 2007, is made by **Rational Enterprises Limitada**, a limited liability corporation (company no. 3-102-300000), whose registered office is c/o Facio Abogados, 3rd Floor, El Patio Building, Plaza Roble Corporate Centre, Guachipelin Escazu, Costa Rica (the "Assignor") in favour of **Rational Entertainment Enterprises Limited**, a private limited company (company no. 112087C), whose registered office is at 10 Hill Street, Douglas, Isle of Man, IM1 1EF (hereinafter "the Assignee").

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of and any official of any jurisdiction or jurisdictions, whose duty it is to issue and record registrations on any application, to record Assignee as owner of the Trademarks and to issue any and all registrations, including renewals thereof, to Assignee, its successors, assigns, nominees or other legal representatives. Assignor hereby represents and covenants that it has the full right to convey the entire interest herein assigned, and that it has not executed and will not execute any agreement in conflict with this Assignment.
