## RELEASE OF TRADEMARK SECURITY INTERESTS

**THIS RELEASE OF TRADEMARK SECURITY INTERESTS** is granted as of May 30, 2007 in favor of Golden Bear International, Inc., a Florida corporation with an office at 11780 U.S. Highway One, Suite 500, North Palm Beach, Florida, 33408 (GBI) by Northern Trust, NA, as successor in interest to Northern Trust Bank of Florida, NA, a national banking association, with an office at 11301 U.S. Highway One, North Palm Beach, Florida, 33408 (Northern Trust).

**WHEREAS**, pursuant to that certain Trademark Security Agreement executed November 9, 2006, between GBI and Northern Trust ("the Trademark Security Agreement"), GBI granted a security interest to Northern Trust in and on all of its right, title and interest in and to certain trademarks, referred to therein as the Marks; and

**WHEREAS**, such Trademark Security Agreement was recorded within the records of the United States Patent and Trademark Office at reel 3429, frame 0344 on November 16, 2006; and

**WHEREAS**, Northern Trust desires to formally release its security interest and all right, title and interest of Northern Trust in and to the Marks.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

- A. Northern Trust does hereby release and forever discharge and reconvey to GBI all of Northern Trust's security interest in, to and under the trademarks, trademark registrations and applications identified on Schedule A attached hereto, together with the goodwill associated therewith (collectively, the "Released Secured Property");
- B. Northern Trust acknowledges and affirms that all of the rights and remedies of Northern Trust with respect to the security interest concerning the Released Secured Property have been and are hereby extinguished;

- C. At GBI's expense, Northern Trust further agrees to perform all additional acts reasonably necessary (including executing additional documents that are reasonably requested) to confirm that Northern Trust has no interest of any type in, to, or under the Released Secured Property; and
- D. Northern Trust represents and warrants that it has not transferred, pledged, or otherwise encumbered any of its rights in the Trademark Security Agreement and that it has all requisite power and authority to execute this RELEASE OF TRADEMARK SECURITY INTERESTS.
