**CERTIFICATE OF AMENDMENT TO THE  
CERTIFICATE OF INCORPORATION  
OF CORELOGIC SYSTEMS, INC.**

CoreLogic Systems, Inc., a Delaware corporation (the "Corporation"), originally incorporated on May 24, 2004 under the original name of "C&S Valuation Technologies, Inc.," a corporation organized and existing under the Delaware General Corporation Law, hereby certifies as follows for the purposes of amending its Second Amended and Restated Certificate of Incorporation:

**FIRST:** The Amended and Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on June 8, 2004 under the name "C&S Valuation Technologies, Inc."

**SECOND:** The Certificate of Amendment of C&S Valuation Technologies, Inc. changing its name from "C&S Valuation Technologies, Inc." to "CoreLogic Systems, Inc." was filed with the Secretary of State of the State of Delaware on October 17, 2005.

**THIRD:** The Certificate of Amendment of CoreLogic Systems, Inc. was filed with the Secretary of State of the State of Delaware on December 6, 2005.

**FOURTH:** The Second Amended and Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on December 28, 2006.

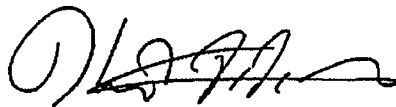
**FIFTH:** The Second Amended and Restated Certificate of Incorporation of the Corporation is hereby amended to change the name of the Corporation by striking ARTICLE I in its entirety and inserting the following new ARTICLE I:

**"ARTICLE I**

The name of this corporation shall be: First American CoreLogic, Inc."

**SIXTH:** This Certificate of Amendment to the Certificate of Incorporation of the Corporation was duly adopted by the Board of Directors and stockholders of the Corporation, in accordance with the provisions of Sections 141(f), 228 and 242 of the Delaware General Corporation Law.
