**DEED OF ASSIGNMENT OF  
INTELLECTUAL PROPERTY RIGHTS**

**PARTIES**

- 1 Seller **APW UK Limited (in administration)** (company no 05877056) whose registered office is at c/o Kroll Limited, 10 Fleet Place, London EC4M 7RB acting by the Administrators;
- 2 Administrators **Andrew John Pepper and Neil Hunter Cooper** its joint administrators both licensed insolvency practitioners of Kroll Limited, 10 Fleet Place, London EC4M 7RB in their respective capacities as joint administrators of the Seller;
- 3 APWEL **APW Electronics Limited (in administrative receivership and liquidation)** (company no. 00701364) whose registered office is at 38 Langham Street, London W1W 7AR acting by the Administrative Receivers;
- 4 Administrative Receivers **Andrew John Pepper and Alastair Paul Beveridge** its joint administrative receivers both licensed insolvency practitioners of Kroll Limited, 10 Fleet Place, London EC4M 7RB in their respective capacities as joint administrative receivers of APWEL; and
- 5 Buyer **CommScope Inc. of North Carolina** (a company registered in North Carolina under company no. 32725) whose registered office is at 1100 CommScope Place, SE, P.O. Box 339, Hickory, North Carolina 28603-0339.

**RECITALS**

(A) The Seller purchased the business and assets of APWEL, acting by the Administrative Receivers, on 26 July 2006 pursuant to the APWEL Sale Contract.

(B) The Administrators were appointed as joint administrators of the Seller by a notice of appointment filed at the High Court on 22 January 2007.

(C) The Seller, acting by the Administrators, and APWEL, acting by the Administrative Receivers, have agreed to assign such right, title and interest as they may have in and to the Intellectual Property Rights, to the Buyer, who has agreed to take such assignment, pursuant to the Agreement.

## OPERATIVE PROVISIONS

### 1 Definitions and interpretation

- 1.1 In this Deed, the "Agreement" means the agreement of even date between the Seller, the Administrators, APWEL, the Administrative Receivers and the Buyer or the sale and purchase of certain assets of the Seller.
- 1.2 Words and expressions used but not defined in this Deed shall have the same meanings as specified in the Agreement.
- 1.3 Unless the contrary intention appears, the following definitions apply:

*Intellectual Property Rights* all of the following intellectual property rights:

(a) the patents and patent applications listed in Part 1 of Schedule 1 of this agreement (the "Scheduled Patents"), along with all foreign counterparts, divisionals, continuations, continuations-in-part, re-examinations and re-issues of the Sellers patents and any amendment of any such patent resulting from re-examination;

(b) the trademarks and trademark applications listed in Part 2 of Schedule 1 of this agreement (the "Scheduled Trademarks"), along with any foreign counterparts;

(c) any unpatented inventions, and all drawings (whether in paper or electronic format), machine software code, tooling, tooling information, trade names, service marks, trade dress, trade secrets, technical know-how, copyrights, copyright registrations, applications for copyright registrations, research and development information, licences to third party technology,

the benefit of any licences granted in any of the foregoing (including, subject to clause 8 of the Agreement the rights to any royalties payable) and any other related Intellectual property of any kind whatsoever that are associated with the Intellectual property rights listed in Schedule 1 of this agreement; and

(d) any other intellectual property rights necessary for the Buyer to make or have made, market, use, import or sell, on a worldwide and exclusive basis, the "IMnet", "IMserve", "IMpatch" and "RAFT" products previously purchased by the Buyer or any of its affiliates from the Seller.

## 2 **Assignment**

The Seller, acting by the Administrators, and APWEL, acting by the Administrative Receivers, hereby assigns, and the Buyer hereby takes and agrees to hold the same unto the Buyer absolutely such right, title and interest as the Seller and APWEL may have in and to the Intellectual Property Rights including (without limitation) the right to sue or to commence proceedings in respect of every act of infringement occurring in relation to the Intellectual Property Rights occurring prior to the date of this Deed.

## 3 **General**

- 3.1 The Buyer acknowledges and agrees that the Administrators act at all times as the agents of the Seller and without personal liability.
- 3.2 The Buyer acknowledges and agrees that the Administrative Receivers shall incur no personal liability by reason of acting in the name of and on behalf of APWEL.
- 3.3 The Buyer acknowledges that the provisions of the Agreement where applicable by their context (and in particular, without limitation, the provisions of clause 10 and Schedule 1 of the Agreement) shall take effect as if set out in full in this Deed of Assignment and shall take effect in favour of the Administrators and the Administrative Receivers as well as of the Seller and APWEL.

3.4 Any stamp duty or other tax arising out of the execution and delivery of this Deed of Assignment shall be for the Buyer's account.


3.5 The Seller and APWEL shall promptly on execution of this Deed of Assignment execute and deliver (at the Buyer's cost) such further documents and do such things as the Buyer may reasonably require to give effect to the assignment affected by this Deed of Assignment.

4 **Proper law**

The construction, validity and performance of this Deed of Assignment shall be governed by and construed in accordance with English Law and the parties submit to the exclusive jurisdiction of the English courts.


