Assignor does hereby sell, assign, convey, transfer and set over to Assignee all of Assignor's right, title, and interest in and to the Marks, together with the goodwill of the business appurtenant thereto and all causes of action for any and all past, present, and future infringement of the rights being assigned and the right to receive and retain the proceeds or other remedies relating to those infringements.

Assignor hereby authorizes the Commissioner of Patents and Trademarks of the United States, and the empowered officials of all governments anywhere in the world, to issue or transfer all of the Marks listed herein to Assignee and to record Assignee as assignee of the entire right, title and interest therein.




