TRADEMARK ASSIGNMENT



ASSIGNOR further assigns and transfers to ASSIGNEE whatever cause of action ASSIGNOR may have for any past or present infringement of said MARK, together with the right to bring suit for any such infringement and to seek and receive damages and other relief arising from any such infringement.
