## **RELEASE AND REASSIGNMENT OF TRADEMARK**

This **RELEASE AND REASSIGNMENT OF TRADEMARK** (this "Release and Reassignment") is made as of May 25, 2007 by **GENERAL ELECTRIC CAPITAL CORPORATION** (the "Bank"), in favor of **ALLIED HOLDINGS, INC.**, a Georgia corporation, **ALLIED SYSTEMS, LTD. (L.P.)**, a Georgia limited partnership and **COMMERCIAL CARRIERS, INC.**, a Michigan corporation (collectively, the "Companies").

### **PRELIMINARY STATEMENT**

A. Companies granted to the Bank a security interest in that certain trademark, which is listed under Registration Number, 3,049,043, and Serial Number, 78-433923, and more particularly described on Exhibit A attached hereto (the "Intellectual Property"), in order to secure certain financing arrangements provided to the Companies by the Bank (the "Financing Arrangement"). Such security interest in the Intellectual Property was recorded on September 15, 2005 with the United States Patent and Trademark Office at Reel and Frame Numbers, 3228/0150.

B. All of the loans made by the Bank to Companies have been paid in full, and the Financing Arrangement has been terminated. The Bank therefore wishes to release the security interest granted in the Intellectual Property, to reassign the Intellectual Property to the respective Companies and to provide the Companies with evidence of such release and reassignment in a form capable of recordation with the United States Patent and Trademark Office.

In consideration of the premises set forth herein and for other good and valuable consideration, the Bank hereby agrees as follows:

1. The Bank hereby releases its security interest in and to and lien on the Intellectual Property and reassigns all its right, title and interest in and to the Intellectual Property to the respective Companies.
2. This Release and Reassignment shall be governed by and construed and enforced in accordance with the laws of the State of New York.
