WHEREAS, the Parties desire that the Registration and ASSIGNOR'S rights, if any, to the Mark, be assigned in full to ASSIGNEE.


WHEREAS, the Parties also desire to conclude the Cancellation Proceeding.



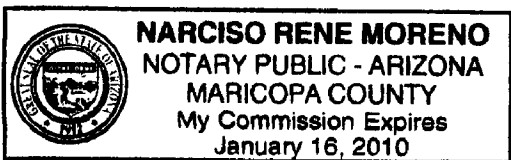
