TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (this "Agreement"), dated as of May 31, 2007, between NICKLAUS COMPANIES, LLC, a Delaware limited liability company ("Borrower"), certain of the direct or indirect subsidiaries of Borrower (collectively with Borrower, "Grantors"), and EMIGRANT BANK GB LLC (the "Lender").

W I T N E S S E T H :

WHEREAS, the Lender and the Grantors are parties to that certain Term Loan and Guaranty Agreement dated as of May 25, 2007 (as amended, modified, restated or otherwise supplemented from time to time, the "Loan Agreement");

WHEREAS, concurrently with the execution and delivery of this Agreement, the Lender and the grantors are entering into a Security and Pledge Agreement of even date herewith (the "Security Agreement"), pursuant to which the Grantors have granted to the Lender a pledge and security interest in all of the Grantors' right, title and interest in the Collateral, including the Trademarks; and

WHEREAS, pursuant to the Security Agreement, the Grantors are required to execute and deliver this Agreement.

NOW, THEREFORE, in consideration of the premises and in order to induce the Lender to make the Loan as set forth in the Loan Agreement, the Grantors hereby agree with the Lender as follows:

Section 1. Defined Terms

Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

Section 2. Grant of Security Interest in Trademarks

Grantors hereby grant to the Lender a pledge and security interest in all of the Grantors' right, title and interest in and to the Trademarks, including the Trademarks listed in Schedule A, in each case whether owned or existing or hereafter acquired or arising and wherever located (collectively, the "Trademark Collateral") provided that applications filed in the U.S. Patent and Trademark Office to register trademarks or service marks on the basis of any Grantor's "intent to use" such marks will not be deemed Trademark Collateral unless and until the filing of a "Statement of Use" or "Amendment to Allege Use" has been filed and accepted in the United States Patent and Trademark Office, whereupon such applications shall be automatically subject to the security interest granted herein and deemed included in the Trademark Collateral.

Section 3. Security for Obligations

This Agreement and the Trademark Collateral secure the payment of all Secured Obligations of each of the Grantors, now or hereafter existing.

Section 4. Security Agreement

The security interests granted pursuant to this Agreement are granted in conjunction with the security interests granted to the Lender pursuant to the Security Agreement and the Grantors hereby acknowledge and affirm that the rights and remedies of the Lender with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event of any irreconcilable conflict between the terms of this Agreement and the terms of the Security Agreement, the terms of the Security Agreement shall control.


