RELEASE OF SECURITY INTEREST

WHEREAS, on May 19, 2006, The Mills Limited Partnership, a Delaware limited partnership with offices at 5425 Wisconsin Avenue, Suite 500, Chevy Chase, MD 20815 ("Assignee"), granted a security interest (the "Security Interest") in the trademarks and federal trademark registrations shown on the attached Schedule A (collectively, the "Marks") to Goldman Sachs Mortgage Company, a New York limited partnership ("Goldman Sachs");

WHEREAS, Goldman Sachs caused the Security Interest to be recorded with the U.S. Patent and Trademark Office against the federal registrations for the Marks at Reel/Frame 3316/0095 on May 24, 2006;

WHEREAS, pursuant to that certain Loan Purchase and Agency Assignment Agreement dated January 30, 2007, Goldman Sachs assigned all of its right, title, and interest in and to the Security Interest to Brookfield Asset Management Inc., an Ontario corporation with offices at BCE Place, Bay/Wellington Tower, 181 Bay Street, Suite 300, Toronto, Ontario, Canada M5J 2T3 (the "Assignor"); and

WHEREAS, Assignor desires to release its rights as a mortgagee, pledgee, and secured party in connection with the Marks under the aforementioned agreements related to the Security Interest, and Assignee desires to accept the release of the Security Interest and lien on the Marks.

NOW THEREFORE, for good and valuable consideration paid by Assignee, receipt of which is hereby acknowledged, Assignor hereby releases the mortgage, pledge, and Security Interest in and to the Marks, releases all other rights it may have under said agreements related to the Security Interest with respect to the Marks, and cancels such agreements with respect to the Marks, effective as of the date written below.
