**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of June 5\_\_\_, 2007, is made by BARCLAYS BANK PLC, as Administrative Agent ("Barclays"), in favor of WATER SOFT INC. ("Water Soft") as follows:

**WITNESSETH**

WHEREAS, pursuant to the Security, Pledge and Guarantee Agreement between Water Soft and Barclays dated December 22, 2006 and the Trademark Security Agreement dated December 22, 2006 ("Trademark Security Agreement"), Water Soft granted Barclays a security interest ("Security Interest") in all right, title and interest of Water Soft in and to the Trademark Collateral (as defined in the Trademark Security Agreement and including, without limitation, the trademark listed on Schedule A attached hereto). Capitalized terms used herein without definition are used as defined in the Security, Pledge and Guarantee Agreement and the Trademark Security Agreement;

WHEREAS, the Trademark Security Agreement was recorded with The United States Patent and Trademark Office on December 22, 2006 at Reel/Frame No. 003449/0944;

WHEREAS, Water Soft has requested that Barclays release its security interest in all right, title and interest of Water Soft in and to the trademarks and all applications and registrations therefore, including goodwill, set forth in Schedule A.

NOW, THEREFORE, Barclays, without recourse, representation or warranty and at Water Soft's sole cost and expense, hereby TERMINATES, RELEASES and DISCHARGES its Security Interest in the Trademark Collateral, and any right, title or interest of Barclays in such Trademark Collateral shall hereby cease and become void.

Barclays agrees to provide Water Soft with any information and additional authorization necessary to effect the release such Security Interest.
