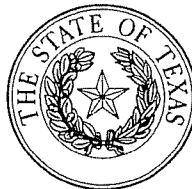

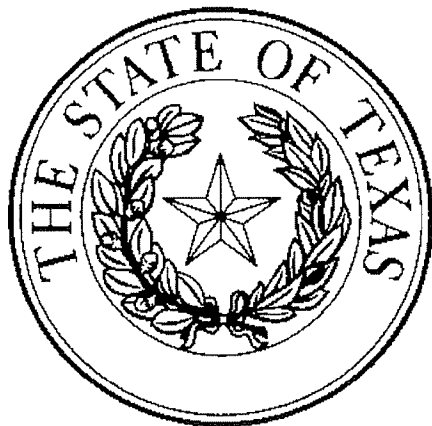

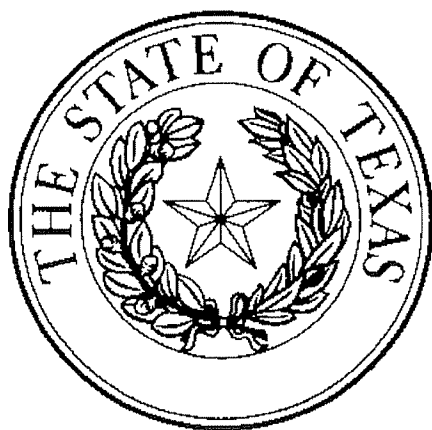

ARTICLES OF CONVERSION
OF
CONTINENTAL SILVERLINE PRODUCTS, INC.

Corporations Section

Pursuant to the provisions of Article 5.18 of the Texas Business Corporation Act, Continental Silverline Products, Inc. certifies that the following Articles of Conversion were adopted for the purpose of effecting a conversion in accordance with the provisions of the Texas Business Corporation Act.

1. Names of Converting Entity and Converted Entity. A plan of conversion was approved and adopted in accordance with the provisions of Article 5.17 of the Texas Business Corporation Act providing for the conversion of Continental Silverline Products, Inc., a Texas corporation organized under the Texas Business Corporation Act (the "*Converting Entity*") to Continental Silverline Products, L.P., a Texas limited partnership organized under the Texas Limited Partnership Law (the "*Converted Entity*").

2. Plan of Conversion Location. An executed plan of conversion is on file at the principal place of business of the Converting Entity at 710 North Drennan, Houston, Texas 77003 and, from and after the conversion, an executed plan of conversion will be on file at the principal place of business of the Converted Entity at 710 North Drennan, Houston, Texas 77003.

3. Plan of Conversion Availability. An executed copy of the plan of conversion will be on written request furnished without cost by the Converting Entity (prior to the conversion) or by the Converted Entity (after the conversion) to any shareholder or partner of the Converting Entity or the Converted Entity.

4. Formal Approval. The approval of the plan of conversion was duly authorized by all action required by the laws under which the Converting Entity was incorporated and by its constituent documents. The Converting Entity has 87,505 shares of common stock outstanding, all of which voted in favor of the plan of conversion.

5. Assumption of Fees and Franchise Tax Liability. The Converted Entity will be responsible for all fees and franchise taxes applicable to the Converting Entity, and the Converted Entity will be obligated to pay all such fees and franchise taxes if such fees and franchise taxes are not timely paid.

Entity Name and Type**
