TRADEMARK ASSIGNMENT

WHEREAS, Jetz Inc., a corporation formed under the laws of NEW JERSEY, with an address of 36 Daniel Drive Franklin Park NEW JERSEY 08823 hereinafter referred to as ("Assignor"), has filed a U.S. Trademark Application based on intent-to-use for the mark DUCK & COVER, and the U.S. Patent and Trademark Office has assigned serial number 78549325 to the Assignor's intent-to-use application and the application covers the mark "DUCK & COVER ("the Mark") in connection with the following goods:

Clothing, namely, pants, jackets, shirts, blouses, dresses, undergarments; headwear and footwear;

Whereas the United States Patent and Trademark Office has published the Assignor's application number 78/549,325 (the '325 application") for opposition by third parties who believe they may be damaged by registration of the Mark as appears in the '325 application;


WHEREAS, Duck and Cover Clothing Limited, a corporation formed under the laws of ENGLAND AND WALES, with an address of 52 Gorst Road Park Royal London UNITED KINGDOM NW10 6LD (hereinafter referred to as Assignee), has filed an extension of time to oppose the '325 application in view of Assignee's trade name being identical to the Mark; Assignee is the owner of pending U.S. Trademark Application serial number 79/018640 for the mark DUCK AND COVER covering clothing goods; and Assignee is desirous of acquiring the '325 application for the Mark and all rights to the mark based in common law or otherwise attributable to the inchoate '325 application;

NOW THEREFORE, in consideration of and in exchange for Ten Thousand Dollars (\$10,000.00) consideration, the receipt of which is hereby acknowledged, Assignor does hereby sell, assign, transfer and set over to Assignee the entire right, title, and interest in and to the Mark, together with the goodwill of the entire portion of the business symbolized by the Mark, and the trademark application thereof.


The parties agree that the substantive trademark laws of England and Wales govern this assignment agreement in the event of any conflict of laws. The parties agree to sign additional documentation as may be necessary to effectuate the intent of the parties to transfer the '325 application or any resulting registration to the control of the Assignee.

This agreement may be signed in counterparts and facsimile signatures are binding as original signatures.
