RESOLUTION REGARDING TRADEMARK ASSIGNMENT**

THIS ASSIGNMENT from UCB Merger, LLC, ("UCB Merger"), a Delaware Corporation, to United Commercial Bank ("UCB"), a California banking corporation, transfers trademarks held by Summit Bank Corporation ("Summit"), a Georgia corporation, to UCB, its successor in interest.

WHEREAS, on December 29, 2006, Summit Bank Corporation ("Summit") merged into UCB Merger. Under this merger, all of Summit's assets merged into UCB Merger, and Summit ceased to operate as an independent entity.

WHEREAS, all of UCB Merger's shares of Summit National Bank were transferred to UCB on December 29, 2006, as planned during the merger of Summit and UCB Merger.

WHEREAS, Summit Bank Corporation held the trademarks and service marks identified in Schedule A (the "Marks").

NOW, THEREFORE, IT IS RESOLVED THAT because UCB is a successor to the business of Summit, UCB Merger hereby transfers all rights, title, interest, and goodwill in the Marks to UCB as the successor to Summit Bank Corporation.
