### ASSIGNMENT OF TRADEMARK

NOW, THEREFORE, in consideration of the payment of certain sums set forth in the Vereinbarung executed between the parties, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell, assign and transfer to Assignee all right, title and interest in and to the Trademark, together with the good will of the business symbolized thereby.



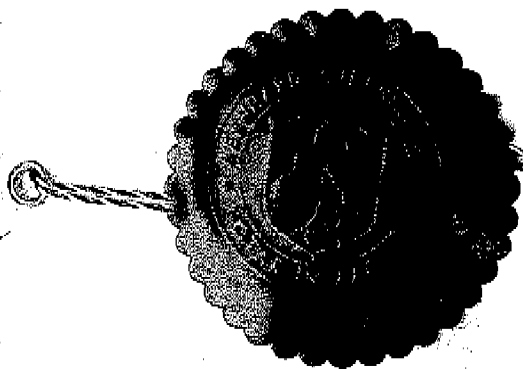

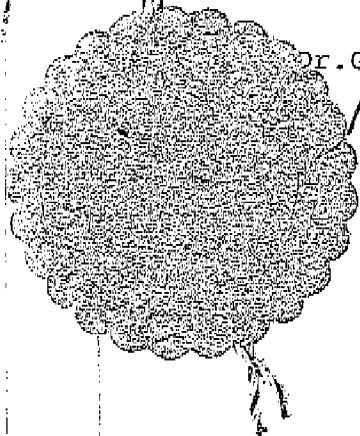
