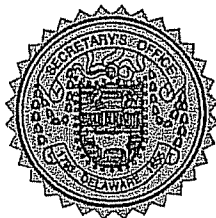

FIRST: That by vote of the members of the board of directors of the Corporation, resolutions were duly adopted setting forth a proposed amendment of the Certificate of Incorporation of the Corporation and declaring said amendment to be advisable to the sole stockholder of the Corporation and in the best interest of the Corporation. The resolution setting forth the proposed amendment is as follows:

WHEREAS, in connection with the Merger and the filing of the Certificate of Merger the Board has determined that it is in the best interest of the Company that the Company change its name from Enovia Corp. to Dassault Systemes Americas Corp.,

NOW THEREFORE BE IT RESOLVED, that the Board hereby recommends the change of the name of the Company to the sole stockholder of the Company pursuant to that certain Certificate of Amendment to amend the Certificate of Incorporation of the Company, a copy of which shall be distributed to the sole stockholder.
