**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
RC2 SOUTH, INC.**

Pursuant to §55-10-06 of the General Statutes of North Carolina, the undersigned Corporation hereby submits the following Articles of Amendment for the purpose of amending its Articles of Incorporation:

- 1. The name of the Corporation is RC2 South, Inc.
- 2. The text of each amendment adopted is as follows:


Section 1 of the Articles of Incorporation of the Corporation is hereby amended and restated in its entirety to read as follows:

“The name of the corporation is Press Pass, Inc.”

- 3. The amendment does not provide for an exchange, reclassification, or cancellation of issued shares.
- 4. The date of adoption of the amendment was November 2, 2006.
