**PARTIAL RELEASE OF SECURITY INTEREST IN INTELLECTUAL
PROPERTY**

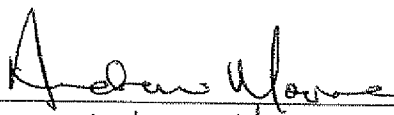
Reference is hereby made to that certain Intellectual Property Security Agreement, dated as of May 24, 2006 (as amended and supplemented from time to time prior to the date hereof, the "**IP Security Agreement**"), executed by **MEDPOINTE HEALTHCARE INC.**, a Delaware corporation ("**Grantor**") located at 265 Davidson Avenue, Suite 300, Somerset, NJ 08873-4120 in favor of **GENERAL ELECTRIC CAPITAL CORPORATION**, a Delaware corporation (the "**Administrative Agent**"), acting in its capacity as Administrative Agent for the Lenders (as such terms are defined in the IP Security Agreement), pursuant to which the Grantor assigned, granted, conveyed, pledged, hypothecated and transferred to Administrative Agent (on behalf of itself and the Lenders) a security interest in and to all of Grantor's right, title and interest in and to its respective trademarks and trademark licenses and patent and patent licenses, and the goodwill associated with the foregoing and all continuations or extensions of the foregoing, and all products and proceeds of the foregoing, as more fully described in the IP Security Agreement; and

WHEREAS, Administrative Agent wishes to release its security interest in a portion of the trademarks and trademark licenses pledged pursuant to the IP Security Agreement, as more fully set forth on Schedule I attached hereto (the "**Released Collateral**") and retransfer and reassign to each Grantor, without representation or warranty, and without recourse, all of the Administrative Agent's right, title and interest in and to the Released Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby releases any security interest it may have in the Released Collateral and retransfers and reassigns to each Grantor, without representation or warranty, and without recourse, all of the Administrative Agent's right, title and interest in and to the Released Collateral.

IN WITNESS WHEREOF, Administrative Agent has executed this Partial Release of Security Interest in the Released Collateral on behalf of itself and the Lenders as of this 12th day of June, 2007.
