SIXTH: The executed agreement of merger is on file at the principal place of business of CMP Media LLC, at 600 Community Drive, Manhasset, New York 11030.


SEVENTH: A copy of the agreement of merger will be furnished by CMP LLC, on request and without cost, to any member of LR LLC or CMP LLC.
