Termination letter Royal Schouten Group

Date: *November 16, 2006*

1 Interpretation

We refer to the EUR 42,500,000 Senior Credit Facilities Agreement dated 22 June 2004 between Royal Schouten Group Holding B.V. and Coöperatieve Centrale Raiffeisen-Boerenleenbank B.A., as amended and restated 23 December 2005 ("the Agreement"), and the Deed of Pledge of Intellectual Property Rights dated 22 June 2004 between Royal Schouten Group N.V., Schouten Products B.V. and Schouten Industries B.V., each as Pledgor, and Coöperatieve Centrale Raiffeisen-Boerenleenbank B.A. as Pledgee ("the Deed of Pledge").

Capitalised terms defined in the Deed of Pledge have the same meaning when used in this letter unless expressly defined in this letter.

2 Termination

a) According to article 10 (*Termination*) of the Deed of Pledge, the deed and the Right of Pledge will remain in full force and effect until the unconditional and irrevocable payment and discharge in full of all secured obligations and the termination of all commitments of the Lender under the Finance Documents.

b) Coöperatieve Centrale Raiffeisen-Boerenleenbank B.A. (as Lender) hereby confirms the unconditional and irrevocable payment and discharge in full of all secured obligations and the termination of all commitments of the Lender under the Finance Documents.

c) Coöperatieve Centrale Raiffeisen-Boerenleenbank B.A. (as Pledgee) hereby terminates in whole the right of pledge created over the Rights by the Deed of Pledge.




