RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of June 1, 2007 ("Effective Date") by and between **CAPITALSOURCE FINANCE LLC**, a Delaware limited liability company ("Assignee"), and **APS HEALTHCARE BETHESDA, INC.**, a Delaware corporation, ("Assignor").

WHEREAS, Assignor and Assignee entered into that certain Amended and Restated Collateral Patent, Trademark, Copyright and License Assignment, dated as of March 29, 2002 (the "Amended and Restated IP Security Agreement");

WHEREAS, the Amended and Restated IP Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") (a) on August 1, 2003 at Reel 2795/Frame 0514, as corrected at Reel 3091/Frame 0849, and (b) on February 2, 2004 at Reel 2908/Frame 0532, as corrected at Reel 3094/Frame 0361;

WHEREAS, the IP Security Agreement was amended by that certain First Amendment to Amended and Restated Collateral Patent, Trademark, Copyright and License Assignment, dated as of June 28, 2007 ("First Amended IP Security Agreement");

WHEREAS, the First Amended IP Security Agreement was recorded with the PTO on June 29, 2005 at Reel 3112/Frame 0957;

WHEREAS, the Amended and Restated IP Security Agreement was further amended by that certain Second Amendment to Amended and Restated Collateral Patent, Trademark, Copyright and License Assignment, dated as of November 13, 2006 ("Second Amended IP Security Agreement") (and together with the Amended and Restated IP Security Agreement and the First Amended IP Security Agreement, the "IP Security Agreement");

WHEREAS, the Second Amended IP Security Agreement was recorded with the PTO on November 17, 2006 at Reel 3430/Frame 0558;

WHEREAS, pursuant to the terms and conditions of the IP Security Agreement, Assignor granted to Assignee a continuing security interest in and to all of Assignor's right, title and interest in and to: (i) all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Assignor, together with the goodwill associated therewith (collectively, the "Trademarks"), including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto, and the United States trademark applications set forth on Schedule B attached hereto; and (ii) all of the copyrights, and registrations of and applications to register the foregoing, owned by Assignor (collectively, the "Copyrights"), including, without limitation, the United States copyright registrations set forth on Schedule C attached hereto; and

WHEREAS, Assignor has paid all of its outstanding indebtedness to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignee hereby terminates the IP Security

Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks and Copyrights.

Assignee shall, at Assignor's expense, take all further actions, and provide to Assignor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Assignor to more fully and effectively effectuate the purposes of this Release.
