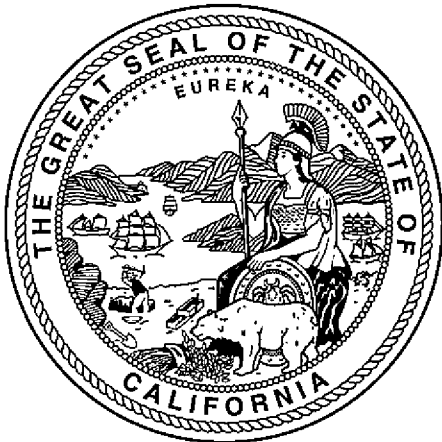

The undersigned certify that:


1. They are the president and the secretary, respectively, of CRG Chemical, Inc., a California corporation.
2. Article I of the articles of incorporation of this corporation is amended to read in full as follows:

The name of this corporation is Aculon, Inc. (the "Corporation").

3. The foregoing amendment of articles of incorporation has been duly approved by the board of directors.
4. The foregoing amendment of articles of incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of the corporation entitled to vote with respect to the foregoing amendment was 1,755,805 shares of Common Stock and 2,740,989 shares of Preferred Stock (1,740,989 shares of which are Series A Preferred Stock and 1,000,000 shares of which are Series A-1 Preferred Stock). The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was a majority of the outstanding shares of Preferred Stock and Common Stock voting together as if a single class, with each share of Common Stock entitled to 1 vote, each share of Series A Preferred Stock entitled to 1 vote and each share of Series A-1 Preferred Stock entitled to 1 vote.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.
