COPPERWELD DELAWARE INCORPORATED hereby certifies that:

(1) The name and state of incorporation of each of the constituent corporations are:

(a) Copperweld Corporation, a Pennsylvania corporation; and

(b) Copperweld Delaware Incorporated, a Delaware corporation.

(2) That certain Agreement of Merger dated as of December 3, 1986 has been approved, adopted, certified, executed and acknowledged by Copperweld Delaware Incorporated and by Copperweld Corporation in accordance with the provisions of subsection (c) of Section 252 of the General Corporation Law of the State of Delaware.
