**NOW, THEREFORE**, in consideration of the foregoing recitals and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignor hereby grants, sells, assigns and transfers to Assignee all of the Assignor’s right, title and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, including all past, current or future causes of action for infringement of the same.
2. Assignor hereby authorizes and requests, as appropriate, the United States Patent and Trademark Office to record Assignee as the assignee and owner of the Marks.
3. Assignor represents and warrants to Assignee that it has not heretofore assigned, pledged or otherwise encumbered the Marks, and that the signatory hereto has full power to enter into this agreement and to make the grants herein contained on behalf of Assignor.
4. Assignor hereby agrees, to promptly provide to Assignee, its successors, assigns or other legal representatives, reasonable cooperation and assistance at Assignee’s reasonable request (including the execution and delivery of any and all documentation as may be reasonably required) in the recordation, implementation or perfection of this Agreement.
5. This is the complete Agreement between the parties with respect to the subject matter contained herein and the parties all intend and agree that this Agreement may not be modified or any waiver of terms claimed unless in writing signed by all parties. This Agreement shall be governed by the laws of the Commonwealth of Virginia, exclusive of its conflicts of laws provisions.

6. This Agreement may be executed in counterparts, each of which when taken together shall constitute one and the same original Agreement.

This Agreement shall be effective as of February \_\_, 2007.
