**AMENDED AND RESTATED RELEASE AND REASSIGNMENT  
OF COLLATERAL ASSIGNMENT BY SECURED PARTY**

WHEREAS, Ralph R. Davis, doing business as Travel Insurance Service, was the registrant (the "Registrant") of United States Department of Commerce Patent and Trademark Office Trademark Registration No. 2,531,670 for the mark "Travel Insurance Select" (the "Mark") Registered January 22, 2002 to Ralph R. Davis DBA Travel Insurance Service;

WHEREAS, Ralph R. Davis, doing business as Travel Insurance Service, assigned to Bertholon-Rowland Corp., all of its right, title and interest in and to the Mark, including the good will associated therewith, on November 1, 2002.

WHEREAS, Bertholon-Rowland Corp., a New York corporation, assigned a collateral interest (the "Collateral Assignment") in the Mark, including the good will associated therewith, and the Registration thereof, to Registrant pursuant to and in accordance with a certain security agreement dated November 1, 2002 by and between Registrant (as "Secured Party") and Bertholon-Rowland Corp.; and

WHEREAS, Secured Party now desires to terminate and release the Collateral Assignment and reassign to Bertholon-Rowland Corp. any right, title or interest Secured Party may have in and to the Mark;

WHEREAS, Secured Party filed a document entitled Release of Collateral Assignment by Secured Party dated April 24, 2007 with the United States Patent and Trademark Office on May 1, 2007, which was recorded at Reel/Frame 3532/0694 (the "Release");

WHEREAS, Secured Party desires to amend and restate the Release in its entirety;


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Secured Party, does hereby (i) TERMINATE AND RELEASE the Collateral Assignment and any security interest granted therein, and (ii) solely to the extent that the Collateral Assignment may be deemed an assignment of any right, title or interest in and to the Mark to the Secured Party, REASSIGN to Bertholon-Rowland Corp. any right, title or interest that the Secured Party may have in and to the Mark, including the good will associated therewith. Secured Party does hereby agree to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the termination, release and reassignment of its interest in and to the Mark contemplated hereby.
