
WHEREAS, Sanford is willing to assign to Chartpak its rights, if any, in the Trademark Registration.

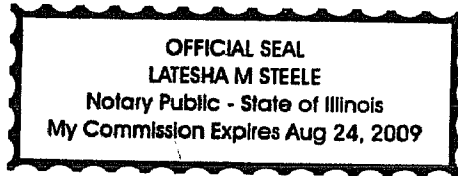
