Assignor further covenants and agrees, and likewise binds its heirs, legal representatives and assigns, to promptly communicate to said Assignee or its representatives any facts known to them relating to said Trademarks, to testify in any interference or legal proceedings involving said Trademarks, to execute any additional papers which may be requested to confirm the right of the Assignee, its representatives, successors and assigns to secure said Trademarks or similar protection for said Trademarks in all countries and to vest in the Assignee complete title to said

Trademarks, without further compensation, but at the expense of said Assignee, its successors, assigns and other legal representatives.
