This Assignment is made by and between BASF CURTEX S.A., a Spanish corporation and BASF AKTIENGESELLSCHAFT, a German corporation;

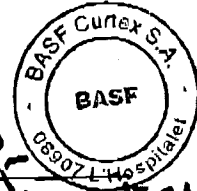
