ASSIGNMENT OF PATENTS AND TRADEMARKS

THIS ASSIGNMENT OF PATENTS AND TRADEMARKS (the "Assignment") is made and entered into as of this 12th day of January, 2000, to be effective as of December 31, 1999, by and between Water-Jel Technologies, LLC, a New Jersey limited liability company ("Assignee"), and Xceed, Inc., a Delaware corporation ("Assignor"),

WITNESSETH:

WHEREAS, Assignor and Assignee entered into an Asset Purchase Agreement, dated as of December 31, 1999 (the "Purchase Agreement"; capitalized terms not defined herein shall have the meanings ascribed to them in the Purchase Agreement), pursuant to which Assignor has agreed to sell, assign, transfer, convey and deliver to Assignee, and Assignee has agreed to purchase from Assignor, the Assets;

WHEREAS, Assignor is the owner of certain patents, trademarks and tradenames set forth on Schedule A attached hereto (which is identical to Schedule 3.10 to the Purchase Agreement (collectively, the "Patents and Trademarks")); and

WHEREAS, in order to evidence Assignee's acquisition of Assignor's right, title and interest in and to the Patents and Trademarks, Assignor desires to execute this Assignment in favor of Assignee;

NOW THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. Assignor hereby assigns and sets over unto Assignee, its successors and assigns:

(a) Assignor's entire right, title and interest in and to the Patents and Trademarks in the United States and in all foreign countries, whether or not such Patents and Trademarks have been registered prior to or after the date of this Assignment, and any and all renewals and extensions thereof, together with the goodwill of the business symbolized by such Patents and Trademarks; and

(b) All claims, demands and rights of action, both statutory and based upon common law, that Assignor has or might have by reason of any infringement of any Patent or Trademark prior to or after the date of this Assignment, together with the right to prosecute such claims, demands and rights of action and to recover damages in Assignee's own name and on Assignee's behalf.

2. Assignor warrants that, upon request by Assignee, Assignor shall execute all papers, instruments, documents and agreements, make all rightful oaths, testify on behalf of Assignee and do all other lawful acts necessary to carry out the intent of this Assignment, as well

provide such other material, information or assistance as reasonably may be necessary to carry out the intent of this Assignment.

3. Assignor hereby constitutes and appoints Assignee the true and lawful attorney of Assignor, with full power of substitution, in the name of Assignor or Assignee, but on behalf of and for the benefit of Assignee: (i) to institute, prosecute, compromise and settle any and all actions or proceedings that Assignee may deem proper in order to collect, assert or enforce any claim, right or title of any kind in or to the Patents and Trademarks; (ii) to defend or compromise any or all actions or proceedings in respect of any of the Patents and Trademarks; and (iii) to do all such acts and things in relation to the matter set forth in the preceding clauses (i) and (ii) as Assignee shall deem desirable. Assignor hereby acknowledges that the appointment hereby made and the powers hereby granted are coupled with an interest and are not and shall not be revocable by it in any manner or for any reason. Assignee shall indemnify and hold harmless Assignor and its officers, directors, employees, agents and affiliates from any and all claims and liabilities Assumed Liabilities caused by or arising out of any breach of law by Assignee in its exercise of the aforesaid powers from and after the date hereof, and as otherwise provided in the Purchase Agreement.

4. This Assignment may not be amended orally, but only by an agreement in writing signed by the party against whom enforcement of any waiver, change, modification, extension or discharge is sought. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

5. The validity, interpretation and effect of this Assignment shall be governed by the laws of the State of New York (excluding the "conflicts of laws" rules thereof), except that if it is necessary in any other jurisdiction to have the law of such other jurisdiction govern this Assignment in order for this Assignment to be effective in any respect, then the laws of such other jurisdiction shall govern this Assignment to such extent.



7. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which, taken together, shall constitute one and the same instrument.


