TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment"), dated as of June 13, 2007, by Accutrac Software, Inc., a California corporation (the "Assignor"), to Iron Mountain Incorporated, a Delaware corporation ("Assignee");

WHEREAS, Assignor owns that certain registered trademark ("Trademark") identified on Schedule A attached hereto and made a part hereof; and

WHEREAS, Assignee wishes to acquire, and Assignor wishes to transfer, all right, title and interest in and to said Trademark, including all rights to sue and recover for past infringement or wrongful use thereof everywhere in the world;

NOW, THEREFORE, in consideration of that certain Asset Purchase Agreement dated June 13, 2007 (the "Asset Purchase Agreement"), the transactions contemplated thereby and other good and valuable consideration, the receipt of which is hereby acknowledged, Assignor agrees as follows:

1. Assignor hereby sells, assigns, transfers and sets over to Assignee all right, title and interest in and to the Trademark, together with the goodwill of the business in connection with which the Trademark is used, and with any and all pending applications, renewals and extensions of the registrations for said Trademark that may be secured under the laws now or hereafter in effect in the United States or any other country or countries.
2. Assignor will provide to Assignee, its successors, assigns or other legal representatives, all reasonable cooperation and assistance (including the execution and delivery of any and all affidavits, declarations, oaths and other documentation, and the delivery of any and all samples, exhibits, specimens and the like in the control of Assignor):
 - A. in the preparation and prosecution of any applications for registration or any applications for renewal of registrations covering the Trademark, at Assignee's expense;
 - B. in the prosecution or defense of any opposition, interference, infringement suits or other proceedings arising from or relating to the Trademark, including testifying as to any facts relating to the Trademark or this Assignment, subject to Assignee providing reasonable compensation to Assignor for its time and expenses related thereto; and
 - C. in the implementation or perfection of this Assignment.
3. In the event of any conflict between the terms of the Asset Purchase Agreement and this Assignment, the terms of the Asset Purchase Agreement shall govern.

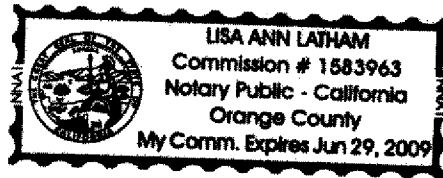
