WHEREAS, it is a condition to the consummation of the transactions under the Merger Agreement that this Agreement be entered into;

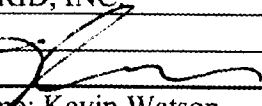

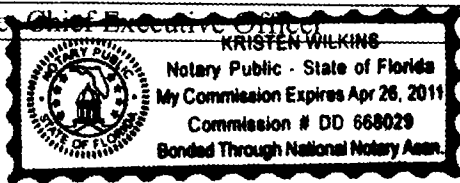
WHEREAS, Parent desires to receive from the Company assignments to the Assigned Trademarks.
