Pursuant to the Alabama Limited Liability Company Act and the Alabama Business Entities Conversion and Merger Act, the undersigned hereby adopts the following Articles of Organization:

1. The name of the limited liability company shall be Tapscan, LLC.
2. The duration of the limited liability company shall be perpetual.
3. The limited liability company has been organized for the following purpose: to engage in any lawful act or activity for which a limited liability company may be organized under the Alabama Limited Liability Company Act.
4. The street address of the limited liability company's registered office is 3000 Riverside Galleria, 8th Floor, Birmingham, Alabama 35244 and the name of the registered agent at that address is Michael W. Hunter.
5. The name and mailing address of the initial member of the limited liability company is Marketrion International, Inc., 411 Airport Boulevard, Burlingame, California 94010.





ARTICLES OF DISSOLUTION  
OF  
TAPSCAN, INCORPORATED

Pursuant to the provisions of the Alabama Business Corporation Act and the Alabama Business Entities Conversion and Merger Act, the undersigned for-profit corporation hereby submits the following Articles of Dissolution:

1. The name of the corporation is Tapscan, Incorporated.
2. The dissolution was authorized on December 15, 2003.
3. The total number of shareholder votes entitled to be cast is 1,000. The number of shareholder votes for the dissolution was 1,000 and the number of shareholder votes against the dissolution was nil.
4. These Articles of Dissolution are being filed pursuant to the conversion of the corporation to a limited liability company organized pursuant to the laws of the State of Alabama. The name of the converted entity is Tapscan, LLC. The formation documents for the converted entity have been filed with the Probate Judge of the County of Jefferson, State of Alabama.
