SECURITY INTEREST ASSIGNMENT

WHEREAS, it is the purpose of this document to evidence the grant of the security interest in a form suitable for recording in the United States Patent and Trademark Office.

NOW, THEREFORE, in consideration received as referenced in the Security Agreement and for other good and valuable consideration, the receipt of which is hereby acknowledged, Debtor grants to Secured Party, subject to and upon the terms of the Security Agreement, a first priority security interest in, a general lien upon, and a right of set-off against, all of Debtor's right, title and interest in and to the trademarks and associated registrations set forth in **SCHEDULE A** attached hereto, as well as a security interest in the proceeds thereof and the goodwill associated therewith.

IN WITNESS WHEREOF, Debtor has caused this instrument to be duly executed as of June 20, 2007.


