ASSIGNMENT NUNC PRO TUNC

WHEREAS, SPX Corporation, a corporation organized under the laws of the State of Delaware, having a place of business at 13515 Ballantyne Corporate Place, Charlotte, North Carolina 28277 (hereinafter "Assignor"), by way of merger of United Dominion Industries, Inc. on December 30, 2003, was the owner of the entire right, title, and interest in and to the following trademark and trademark registration (hereinafter "the Mark");


NOW, THEREFORE, for good and valuable consideration previously paid by Assignee to Assignor, the receipt and sufficiency of which hereby are acknowledged, Assignor and Assignee agree as follows:

Assignor (through its rights acquired via the merger of United Dominion Industries, Inc.) hereby assigns to Assignee, *nunc pro tunc*, as of January 30, 2002, the entire right, title, and interest in and to the Mark, along with the goodwill associated therewith, the same to be held and enjoyed by the Assignee for its own use and enjoyment and for the use and enjoyment of its successors, assigns, or other legal representation. Assignor further assigns to Assignee, *nunc pro tunc*, all the right to sue for past, present, and future infringements, and all rights corresponding thereto throughout the world for the Mark.

This Assignment shall be binding upon the Parties, their successors and/or assignees, and all other acting by, through, with, or under their direction, and all those in privity therewith.
