**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of June 27, 2007, is made by Bank of America, N.A. (f/k/a NationsBank, N.A.), as Agent for itself and other Lenders ("BofA"), in favor of InteliStaf Healthcare, Inc. (f/k/a Wesley Medical Resources, Inc.) ("InteliStaf") as follows:

**W I T N E S S E T H**

WHEREAS, pursuant to the Security Interest dated December 31, 1998 ("Security Interest"), and recorded with The United States Patent and Trademark Office on March 26, 1999 at Reel/Frame No. 1875/0773, on June 7, 2001 at Reel/Frame No. 2311/0612, and on September 19, 2001 at Reel/Frame No. 2373/0807, InteliStaf granted BofA a security interest in its trademarks and registrations therefore, including goodwill (the "Trademark Collateral");

BofA agrees, upon the request of (and at the sole cost and expense of ) InteliStaf, to provide InteliStaf with any information and additional authorization necessary to effect the release of BofA's security interest in the Released Trademark Collateral.
