Trademark Assignment

THIS TRADEMARK ASSIGNMENT (this "Assignment") made as of June 18, 2007, by GUARDIAN BUILDING PRODUCTS DISTRIBUTION, INC., a Georgia corporation ("ASSIGNOR").

WITNESSETH:

WHEREAS, ASSIGNOR is the owner of the tradenames and trademarks set forth on the attached Exhibit A and any and all trade dress associated therewith ("the Marks"), together with the goodwill of the business symbolized thereby in connection with the products on which the Marks are used; and

WHEREAS, in connection with that certain Asset Purchase Agreement by and between ASSIGNOR'S subsidiary Ashley Aluminum, LLC ("Ashley") and AMERICAN BUILDERS & CONTRACTORS SUPPLY CO., INC. ("ASSIGNEE") dated May 4, 2007 (the "Purchase Agreement"), ASSIGNOR desires to convey, transfer, assign, deliver, and contribute to ASSIGNEE of ASSIGNOR'S right, title, and interest in and to the Marks in the United States of America and in all foreign countries (collectively, the "Marks").

NOW, THEREFORE, ASSIGNOR, in consideration of the mutual agreements set forth in the Asset Purchase Agreement between Assignor, or its Affiliate, and Assignee other good and valuable consideration, acknowledged to be sufficient and received, does hereby:


1. **Assignment.** ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR'S right, title, and interest in and to the Marks, together with (a) the goodwill of the business relating to the Marks; (b) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Marks; and (c) all rights to sue for past, present, and future infringements or misappropriations of the Marks. ASSIGNOR further conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all rights in the trade dress, labels, and designs, if any, associated with the Marks.

2. **Further Assurances.** ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Marks. The terms and conditions of the Purchase Agreement shall survive the execution of this Agreement, as expressly provided in the Purchase Agreement.
