ASSIGNMENT OF TRADEMARKS

WHEREAS, Carilion Medical Center, a Virginia nonstock corporation ("CMC"), has adopted and is using in connection with its laboratory business certain service marks, has acquired goodwill associated with and symbolized by said service marks, and has not abandoned the same; and

WHEREAS, CMC is the owner of two registrations of said service marks in the United States Patent and Trademark Office, to-wit: Mark #1: "CCL [& Design]", Reg. No.: 3,011,855, Reg. Date: November 1, 2005; and Mark #2: "CCL Carilion Consolidated Laboratory [& Design]", Reg. No.: 3,015,975, Reg. WHEREAS, as part of a restructuring plan, CMC is transferring all of its laboratory services assets and operations, including the Marks, to its affiliate Carilion Services, Inc., a Virginia nonstock corporation and Carilion Services, Inc. is transferring all of its laboratory services assets and operations, including those received from CMC, to its wholly-owned subsidiary, CHS, Inc., a Virginia corporation, for further consolidation with other laboratory service assets of Carilion Health System;

NOW, THEREFORE, for and in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, CMC does hereby assign unto Carilion Services, Inc. all of its right, title and interest in and to the Marks, together with the goodwill of the business associated with and symbolized by said Marks, and the registrations thereof hereinbefore set forth;

FURTHER, for and in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Carilion Services, Inc. does hereby assign unto CHS, Inc. all of its right, title and interest in and to the Marks, together with the goodwill of the business associated with and symbolized by said Marks, and the registrations thereof hereinbefore set forth.
