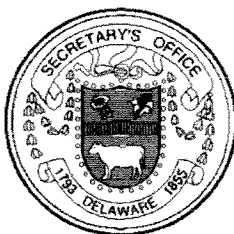

2. The Board of Directors of the Corporation duly adopted the following resolution on July 12, 2002:



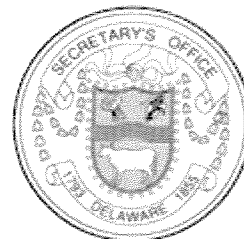
