
ASSIGNMENT OF TRADEMARK APPLICATION



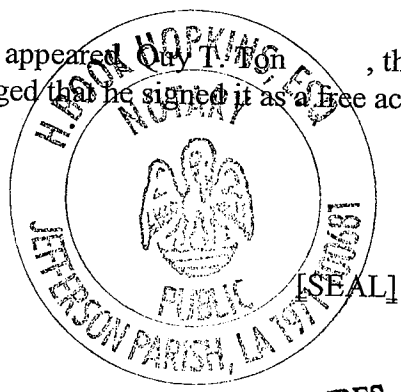
