TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "*Agreement*"), effective as of June 29, 2007, by KV Pharmaceutical Company, a Delaware corporation ("*Assignor*"), is in favor of Drugtech Corporation, a Delaware corporation ("*Assignee*"). Capitalized terms used but not otherwise defined herein shall have the meaning ascribed to such terms in the Purchase Agreement (as defined below).

RECITALS

WHEREAS, KV PHARMACEUTICAL COMPANY, a corporation organized and existing under the laws of Delaware having a place of business at 300 Delaware Avenue, Suite 1270, Wilmington, Delaware 19801 (hereinafter "*Assignor*"), is the owner of the trademark EVAMIST which is applied for in the United States Patent and Trademark Office as Application No. 76/593834, filed May 24, 2004; and

WHEREAS, Drugtech Corporation, a corporation organized under the laws of Delaware having a place of business at 300 Delaware Avenue, Suite 1270, Wilmington, Delaware 19801 (hereinafter "*Assignor*"), is desirous of acquiring the aforesaid trademark EVAMIST, desires to acquire the entire right, title, and interest in the trademarks, together with the portion of the business to which the marks pertain and the goodwill of the business connected with the aforesaid registration therefor.

NOW, THEREFORE, in consideration of good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

AGREEMENT

1. **Assignment of Intellectual Property.** Assignor hereby grants, assigns and conveys to Assignee, and Assignee hereby accepts, all of Assignor's right, title and interest in and to all trademarks set forth on Exhibit A hereto (the "*Assigned Trademarks*"), and the portion of the business to which the Assigned Trademarks pertain (as defined herein) and the goodwill associated therewith. Assignor further grants, conveys and assigns to Assignee all of Assignor's right, title and interest in and to any and all proceeds, causes of action and rights of recovery for past and future infringement of any of the Assigned Trademarks.

2. **Further Actions.** The Assignor further agrees, without further consideration, to cause to be performed such lawful acts and to execute such further assignments and other lawful documents as Assignee may reasonably request to effectuate fully this Agreement.

3. **Assignability.** The parties' rights and obligations under this Agreement will bind and inure to the benefit of their respective successors, heirs, executors, administrators and assigns.
