

FULL RELEASE OF LIEN

This full release of lien, dated as of April 27 2007 (this "Release") is made by Southwest Bank of St. Louis ("Southwest Bank"), successor-in-interest to Missouri State Bank and UGS Corp., a Delaware corporation ("UGS").

WITNESSETH

WHEREAS, pursuant to that certain agreement dated April 1, 2007, Missouri State Bank was acquired by Marshall & Illsley Corp.

WHEREAS, InAir, Inc., a Delaware corporation ("InAir") and Missouri State Bank and Trust Company ("Missouri State Bank") entered into that certain Security and Pledge Agreement, dated January 31, 2001, recorded with the USPTO on February 13, 2001, Reel/Frame: 002239/0961 (the Security and Pledge Agreement"), in favor of Missouri State Bank, for the Collateral as defined in the Security and Pledge Agreement ("the Collateral").

WHEREAS, pursuant to that Notice of Transfer of Ownership, dated May 31, 2002, between E. Rebecca Case, Chapter 7 Trustee for the Chapter 7 Estate of In re InAir, Inc. certain assets were transferred to Electronic Data Systems Corporation, a Delaware corporation ("EDS"), and EDS Information Services, L.L.C., a Delaware limited liability company ("EIS").

WHEREAS, pursuant to that certain Trademark Assignment, effective as of August 22, 2002, EIS assigned certain trademark registrations to EDS.

WHEREAS, pursuant to that certain Assignment dated September 30, 2004, EDS assigned its interest into certain trademark registrations to UGS.

WHEREAS, Southwest Bank, as successor-in-interest, wishes to release all of its interest in the Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Southwest Bank does hereby release, without recourse, representation, or warranty, its entire security interest in, to or under all of the Collateral together with the goodwill of the business symbolized thereby, and any right, title and interest of Southwest Bank in, to and under the Collateral shall hereby cease and become void.

This Release shall be governed by the laws of the State of Texas.
