TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This TERMINATION AND RELEASE is dated as of December ___, 2006, from GE Capital Franchise Finance Corporation, a Delaware corporation (the "Secured Party"), to Eateries, Inc., an Oklahoma corporation (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to the Amended and Restated Memorandum of Security Interest in Trademarks and Registrations, dated as of September 20, 2004, made by the Grantor in favor of the Secured Party (the "<u>Trademark Security Agreement</u>"), a security interest (the "<u>Security Interest</u>") was granted by the Grantor to the Secured Party in the Trademark Collateral (as hereinafter defined);

WHEREAS, upon receipt of the payoff amount (the "Payment Amount") set forth in Secured Creditor's payoff letter dated December 13, 2006 no later than December 31, 2006 (the "Outside Payoff Date"), the Secured Party now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Secured Party hereby states as follows:

- 1. <u>Definitions</u>. The term "<u>Trademark Collateral</u>," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation, those items listed on <u>Schedule A</u> hereto). The term "<u>Trademarks</u>" shall have the meaning provided by reference in the Trademark Security Agreement.
- 2. <u>Release of Security Interest</u>. Upon receipt of the Payment Amount no later than the Outside Payoff Date, the Secured Party hereby terminates, releases and discharges its Security Interest in the Trademark Collateral.
- 3. <u>Further Assurances</u>. Upon the written request of Grantor and at Grantor's sole request, the Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.


