
**GRANT OF SECURITY INTEREST  
IN TRADEMARKS**

This Security Grant is being given in conjunction with the interest to be granted to the Bank under the Security Agreement, and the provisions of this Security Grant are without prejudice and in addition to the Security Agreement, which are incorporated herein by this reference.
