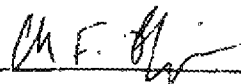

The undersigned corporation, organized and existing under and by virtue of the General Corporation Law of Delaware, DOES HEREBY CERTIFY:

- FIRST: That the name and state of incorporation of each of the constituent corporations of the merger are as follows:
- (a) Zimmer Austin, Inc., a Delaware corporation (the "Non-Surviving Corporation"); and
 - (b) Zimmer, Inc., a Delaware corporation (the "Surviving Corporation").
- SECOND: That an Agreement and Plan of Merger, by and between the Surviving Corporation and the Non-Surviving Corporation, has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with the requirements of Section 251 of the General Corporation Law of Delaware.
- THIRD: That the name of the Surviving Corporation is "Zimmer, Inc."
- FOURTH: That the Certificate of Incorporation of Zimmer, Inc., a Delaware corporation that is surviving the merger, shall be the Certificate of Incorporation of the Surviving Corporation.
- FIFTH: That the executed Agreement and Plan of Merger is on file at an office of the Surviving Corporation at 345 East Main Street, Warsaw, Indiana 46580.
- SIXTH: That a copy of the Agreement and Plan of Merger will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of either of the constituent corporations.
- SEVENTH: That this Certificate of Merger shall be effective on January 31, 2006
