NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, said Assignor does hereby sell, assign and transfer unto said Assignee, its successors and assigns, the entire right, title and interest of Assignor in and to the Marks, together with the goodwill of the business in connection with which the Marks are used, including all rights and claims for damages and benefits arising because of past infringement of the Marks.
