GRANT OF SECURITY INTEREST

IN TRADEMARKS

GRANT OF SECURITY INTEREST, dated as of July 3, 2007, by MicroNets, Inc. d/b/a Vidavee, a Delaware corporation (together with its successors and assigns, "Debtor"), in favor of Trident Capital, Inc., as collateral agent ("Collateral Agent") for the benefit of the Investors (the "Investors") named in the Security Agreement (as defined below).

Recitals

A. Reference is made to the Security Agreement, dated as of the date hereof (as amended, restated or supplemented from time to time, the "Security Agreement"), by and among Debtor, Collateral Agent and the Investors;

B. Debtor has adopted, used and is using the trademarks, more particularly described on Schedule A annexed hereto as part hereof, which trademarks are registered or subject to an application for registration in the United States Patent and Trademark Office (collectively, the "Trademarks");

C. Schedule A hereof constitutes a complete list, as of the date hereof, of registrations or applications for registrations of Trademarks in or to which Debtor has any right, title, interest, claim or demand. After the date of the Security Agreement, the terms and provisions of which are hereby incorporated herein as if fully set forth herein, Debtor shall provide written notice to Collateral Agent, in accordance with the provisions of the Security Agreement, of any addition or change which is necessary to be made to Schedule A in order to maintain such schedule's completeness or accuracy.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Debtor hereby grants to Collateral Agent a security interest to secure the prompt payment, performance and observance of the Obligations, as defined in the Security Agreement, in all right, title and interest of Debtor in and to all Trademarks, together with the goodwill of the business symbolized by the Trademarks and the customer lists and records related to the Trademarks and the applications and registrations thereof, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof;

Debtor does hereby further acknowledge and affirm that the rights and remedies of Collateral Agent with respect to the security interest in the Collateral granted hereby are more fully set forth in the Security Agreement.
