**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK (the "Release"), is granted and conveyed as of this 5<sup>th</sup> day of June 2007, by Deutsche Bank Trust Company Americas, as collateral agent (the "Agent"), in favor of Stiefel Laboratories, Inc. (the "Obligor").

**WITNESSETH:**

WHEREAS, pursuant to that certain Second Lien Security Agreement, dated as of December 28, 2006, by and between Obligor and Agent, among others ("Security Agreement"), Obligor has granted a security interest in certain of its tangible and intangible personal property, including, but not limited to, the trademarks listed on the attached Exhibit A, together with any applications for federal registration or federal registrations therefor (collectively, the "Released Trademark");

WHEREAS, the Security Agreement was filed on behalf of Agent in the United States Patent and Trademark Office, on February 2, 2007 and executed on December 28, 2006 at Reel 3474/ Frame 0713, to evidence the security interest granted to Agent thereunder;

WHEREAS, Obligor has requested that Agent: (a) terminate and release the liens and interests of Agent in the Released Trademark; and (b) execute and deliver evidence of such termination and release for filing in the Patent and Trademark Office; and

WHEREAS, Obligor has satisfied and fulfilled all of its obligations to release the Agent's security interest in the Released Trademark under the Security Agreement, and the parties seek to make a record of Agent's release and reassignments to Obligor of any and all of its security interests in the Released Trademark.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby releases, discharges, and relinquishes its security interests in the Released Trademark. Agent specifically acknowledges that its security interests in the Released Trademark are no longer in force.
