## ASSIGNMENT DEED

This agreement is made and entered by and between

- **Nautor's Swan Servicios de Consultoria Lda.**, (hereinafter referred to also as "NSSC"), with its head offices in 22-2 F. Rua Joao Tavira, Funchal Madeira, represented in this deed by Mr. Enrico Chieffi and Mr. Giorgio Banchini,

- **Oy Nautor AB**, (hereinafter referred to as "ON"), with its head office in Finland, at P.O. Box 10, Pietarsaari, represented in this deed by Mr. Simone Marconcini,

- **Nautor's Swan Europe S.A.M.**, (hereinafter referred to also as "NSE"), with its head offices in 42, Quai Jean Charles Rey, "Le Grand Large", Bâtiment 5, 1er étage, Bureau N° 513, Monaco, 98000, represented in this deed by Mr. Lorenzo Betti  
(hereinafter collectively referred to as "Nautor")

- on the one side - and

- **Nautor's Swan International SA** (hereinafter referred to also as "NSI"), with its head offices in Luxembourg, at 19/21 bld du Prince Henri I, represented in this deed by Mr. Leonardo Ferragamo (President), Mr. Visconti (Director) and Mr. Fazer (Director)

- on the other side -

### WHEREAS:

- a) Through the Assignment Deed executed on June 30, 2003, NSI, ON and Mr. Leonardo Ferragamo assigned to NSSC the ownership of their applications and registrations for

the trademarks "Nautor's Swan", "Nautor", "Swan", "Swan Cup" and "Arrow Device", as set forth in Annexes 1, 2 and 3 respectively;

- b) NSSC is also the owner of the applications and registrations for the trademarks "Nautor's Swan", "Nautor", "Swan Cup", "Swan Class 45", "Swan class 601", "Swan European Regatta", "Swan American Regatta", "Arrow Device" and "Burgee figurative" set forth in Annex 4;
- c) ON is the owner of two German registrations for the trademarks NAUTOR and SWAN, as set forth in Annex 5;
- d) NSE is the owner of a Monaco application for the trademark NAUTOR'S SWAN, as set forth in Annex 6;
- e) Nautor intends to assign the ownership of its trademarks to NSI, which is willing to accept


IN WITNESS THEREOF it is hereby agreed as follows:

1. the premises and annexes constitute an integral and substantial part of this agreement for all legal purposes;
2. Nautor assigns to NSI, which accepts and acquires, the ownership of all its single class and multi class applications and registrations in classes 3, 9, 14, 18, 22, 24, 25, 28, 35, 36, 37, 39 and 41, as set forth in detail in Annex "A" (hereinafter, "the Trademarks");
3. as a consideration for the assignment of the Trademarks, upon execution of this agreement, NSI shall pay Nautor the amount of **REDACTED**
4. all expenses relating to the fiscal registration of this agreement shall be borne by NSSC, which will also bear the costs of recording the assignment of the Trademarks with the competent Patent and Trademark Offices;


5. this agreement is drafted in English in four copies, although translations in other languages are permitted. In case of discrepancy between texts, the original English text shall prevail;
6. this Agreement is governed by Luxembourg law.

This Agreement is entered into and executed on this 15<sup>th</sup> day of December 2004.


