THOMAS R. ADAMS, III, certifies:

1. That he is the President and Secretary of CENTURY DIRECT, INC., a California corporation.

2. Article "FIRST" of the Articles of Incorporation of the corporation is amended to read as follows:


"FIRST: The name of the Corporation shall be: Bargain Network, Inc."

3. The foregoing Amendment to Articles of Incorporation has been duly approved by the Board of Directors.

4. The foregoing Amendment to Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 903 of the California Corporations Code. The total number of outstanding shares of the corporation is eight hundred twenty-four thousand thirty-two (824,032) shares of Class A voting common stock and four hundred thirty-six thousand nine hundred sixty (436,960) shares of Class B nonvoting common stock. The number of shares of each class voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than fifty percent (50%) of the Class A voting common stock.

I further declare under penalty of perjury under the laws of the State of California that the matters set forth in this Certificate are true and correct of my own knowledge.

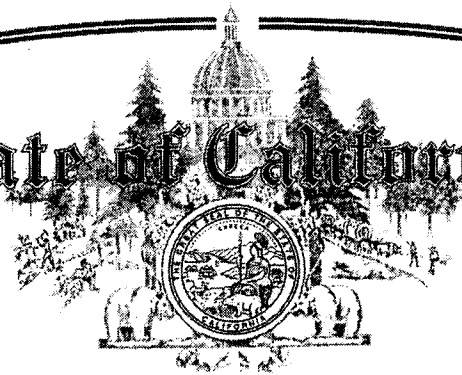
